Initial	<p><b>Consignor Pick Up</b> (of any unsold items I choose not to donate) is <b>Sunday, Oct. 2nd, 2:00pm – 3:00pm</b>          In order to maintain social distancing ~ <b>Sign up is REQUIRED!</b>          I understand that I am responsible for picking my items up <b>by 3:01pm on Sunday, Oct. 2nd</b> or they will be donated to the JBF Charity Partner. JBF is not responsible for storing any items or reminding me to pick up.</p>
Initial	<p>Items that are too worn, stained, outdated, broken, missing pieces or not working will be rejected during Drop Off at the discretion of the JBF Staff. Items are expected to have working batteries. The consignor will be charged \$1/per battery if we need to change/replace to test the item for it to sell.          JBF reserves the right to remove unacceptable items from the sales floor throughout the sale. We will have these items for the consignor at pickup.</p> <p><b>To ensure the best quality items are sold at JBF Fox Cities, we have a 'No Thank-You' fee of .25 cents per item that does not pass inspection (first five 'no thank-yous' are free).</b></p>
Initial	<p>I understand that as a condition of selling items in a Just Between Friends Consignment Sale, I represent the following to be true and correct:</p> <ol style="list-style-type: none"> <li>1. I am the owner of the items to be sold and I have full authority to sell the items offered by me for sale; and</li> <li>2. Each item offered for sale by me is in good operating condition, reasonable wear and tear accepted, and is not broken or damaged in any way; and</li> <li>3. Any repaired item was repaired by the original manufacturer or in accordance with the original manufacturer's warranty program; and</li> <li>4. Each item complies with applicable law, <a href="https://www.cpsc.gov/cpsclist.aspx">https://www.cpsc.gov/cpsclist.aspx</a>; and</li> <li>5. No item is the subject of any pending or threatened recall notice or other consumer protection enforcement action; and</li> <li>6. I know of no reason why any item offered for sale by me would cause injury to another.</li> </ol>
Initial	<p>I understand that a "star" (printed on JBF tags with red or black ink) means that the item will remain at FULL PRICE throughout the sale. Tags with no star means the item will be sold at 50% during 50% off presale, and 50% sale days. For consignors' protection, alterations to the tags (lowering/increasing price or adding/removing a star) will NOT be accepted any time during the sale.</p>
